- III. Report on Building Project by Carl. See attached report. Mostly pricing of cottage and utility work. Asbestos and lead survey has been done; found some asbestos, no lead. Estimated cost to remove: \$3000 to \$5000. Will come from contingency. Architect's contract signed; utility easement signed and notarized. Carl and

Dora meeting with immediate neighbor to the south, Chris Scully, on Thursday afternoon. He stated to Carl that parts of his sewer is also on our property. Will meet with contractor and architect to review City comments after September 28.

- IV. Finance: Profit and Loss Report handed out. After two months, both income and expenses are in line with budget. Holly and Gail meeting soon to review capital budget and accounting; approx. \$110,000 received for project to date.
- V. Committee on Shared Ministry: Nancy and committee working on Anatomy of Trust, plus listening opportunities. Oct 20 and 21? Dora asked what are we listening for?
